Tasks:

- To make a consultation on prescription and OTC drugs and other pharmaceutical products range;
- To make pharmaceutical care when selecting and sale OTC drug by assessing the risk / benefit ratio, interoperability, indications and contraindications guided by data on the health of individual patients taking into account the biopharmaceutical, pharmacokinetic, pharmacodynamic and physicochemical characteristics of drugs and other pharmaceutical products range;
- To ensure the rational use of prescription and over-the-counter drugs and other products of the pharmacy range in accordance with physicochemical, pharmacological characteristics, biochemical, pathophysiological features of a particular disease and pharmacotherapeutic schemes of its treatment;
 - Demonstrate the communication skills of communication.

In the case of distance study form the procedure for conducting an objective structured practical (clinical) examination (OSPE) is governed by the Regulations on the introduction of elements of distance learning in Vinnytsya National Pirogov Memorial Medical University and will take place on the platform Microsoft Teams.

Equipment for distance form OSPE: situational tasks.

At the day of the exam, the secretary of the State Examination Commission joins a student to the meeting of the examiner, a group that passes the exam according to the schedule. At the station, the student must greet and introduce himself, present a document (passport) proving his identity to the teacher. The student receives a practical situational task, which involves determining the algorithm of interviewing a pharmacy visitor according to a particular symptom, identify threatening symptoms that require immediate doctor's examination, choose the right drug, calling its group affiliation, possible side effects, frequency and duration of use, features of interaction with other drugs.

The duration of the station is 8 minutes. Note that the teacher is an observer of your actions and does not provide instructions, comment or question. After the end of the stay at the station, the examiner does not accept the answer. After the signal about the end of the stay, the student must move to the next station.

Requirements for passing the station:

- usage a computer or laptop during the answer;
- the answer is accepted if the camera and microphone are turned on, where the student who passes the exam is clearly visible and audible;

- video is recorded while working at the station.

It is forbidden to use a mobile phone and other electronic gadgets, without answering during the exam, to transmit, copy, make a screenshot and distribute any information related to the exam and not publicly available.

Part of OSPE of Clinical Pharmacy consists of two stations.

An example of evaluating the response of a higher education seeker to a practical (situational) task.

Practical situation. Choose and dispense a drug to relieve cold to a 56-year-old man with hypertension. To do this, perform the following tasks.

- 1) Identify the possible threatening symptoms that occur in the patient when choosing a drug to eliminate the common cold, which require immediate medical attention. What clarifying questions should the pharmacist ask the pharmacy visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible side effects, frequency and duration of use, features of interaction with other drugs

List of situations: pharmaceutical care of patients with the following symptoms: cough; headache; fever; rhinitis; conjunctivitis, sore throat; heartburn; constipation; diarrhea; flatulence; dysbiosis; acne, joint pain, insomnia, anxiety, varicose veins; fungal and viral damage to the skin, when choosing a contraceptive, drugs for the prevention of diseases caused by iodine deficiency.

Practical situation 1

Perform pharmaceutical care for oral contraceptive use in a 35-year-old female smoker. To do this, complete the following tasks.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing contraceptives. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 2

Perform pharmaceutical care regarding the dispensing of an over-the-counter drug for the symptomatic treatment of headache for a 35-year-old woman suffering from migraine. To do this, complete the following tasks.

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing pain killers at headache. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Choose and dispense a medicine for the prevention of diseases caused by iodine deficiency to a 12-year-old child. To do this, complete the following tasks.

Task:

- 1) Identify the possible threatening symptoms that occur in the patient when choosing a drug for the prevention of diseases caused by iodine deficiency, which require immediate medical attention. What clarifying questions should the pharmacist ask the pharmacy visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 4

Perform pharmaceutical care regarding the dispensing of an over-the-counter drug for the symptomatic treatment of fever in a 30-year-old pregnant woman. To do this, complete the following tasks.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing antipyretics. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 5

Perform pharmaceutical care for dispensing an over-the-counter medicine for the symptomatic treatment of constipation to a 75-year-old man on long-term nicardipine. To do this, complete the following tasks.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing laxatives. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 6

Perform pharmaceutical care regarding the release of an over-the-counter drug for the symptomatic treatment of fever in a 4-year-old child with paracetamol allergy in anamnesis. To do this, complete the following tasks.

- 1) Identify the possible threatening symptoms that can occur in the patient with fever, that require immediate medical attention. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Choose and dispense a medicine to relieve diarrhea to a 30-year-old man who is on a business trip. To do this, perform the following tasks.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient with diarrhea, that require immediate medical attention. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 8

Choose and dispense a drug to relieve a runny nose in a 29-year-old woman with seasonal allergic rhinitis. To do this, complete the following tasks.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient with rhinitis, that require immediate medical attention. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 9

Choose and dispense the drug to a 23-year-old woman to relieve symptoms of intestinal dysbiosis after long-term antibacterial therapy. To do this, perform the following tasks.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient with dysbiosis, that require immediate medical attention. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs. Choose a drug that includes a representative of non-pathogenic unicellular yeast fungi.

Practical situation 10

Perform pharmaceutical care regarding the dispensing of an over-the-counter drug for the symptomatic treatment of a sore throat in a 35-year-old man. To do this, complete the following tasks.

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing oral antiseptics. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Perform pharmaceutical care regarding the dispensing of an over-the-counter drug for the symptomatic treatment of a dry cough to a 3-year-old child with symptoms of an acute respiratory viral infection. To do this, complete the following tasks.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing antitussive medicine. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 12

Perform pharmaceutical care regarding the dispensing of an over-the-counter drug for the symptomatic treatment of acne on the face of a 16-year-old girl. Choose a means of local action. To do this, complete the following tasks.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing anti-acne medications. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 13

Perform pharmaceutical care regarding the dispensing of an over-the-counter drug for the symptomatic treatment of flatulence for a 45-year-old man with type II diabetes. To do this, complete the following tasks:

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient with flatulence, that require immediate medical attention. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.

Practical situation 14

Choose and dispense an over-the-counter systemic painkiller for a 72-year-old man with severe left knee pain that increases at walking. The patient has been suffering from osteoarthritis for a long time.

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing pain killers for joint pain. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible benefits depending on the medical form (cream, ointment, gel), side effects, frequency and duration of use, features of interaction with other drugs.

Choose and dispense a drug to reduce a cough with a small amount of sputum in a 75-year-old man.

Tasks:

- 1) Identify the possible threatening symptoms that can occur in the patient, that require immediate medical attention when dispensing antitussives. What clarifying questions should the pharmacist ask a visitor in this situation.
- 2) Justify the choice of drug for this symptom, its group affiliation, possible adverse reactions, frequency and duration of use, features of interaction with other drugs.
