2. Description of the discipline

Short annotation of the course, relevance.

Course "History of World Culture" is aimed at the development of analytical and artistic thinking of students, awareness of the complex processes of modern cultural and artistic life. Thorough knowledge of world culture is one of the most important components of the formation of scientific worldview and education of high moral qualities of modern student youth. Plays an important role in the formation of a harmonious personality of a doctor, general culture and socialization of the individual.

Studying the course is important for a number of reasons:

- to ensure awareness of the complex processes of modern cultural and artistic life of the world;
- to educate students to respect the spiritual and material achievements of mankind, to develop skills of tolerant attitude to ethno-national and social diversity of cultural forms of modern human space;
- the need to systematize, summarize, critically comprehend and adequately assess the accumulated cultural experience;
- formation of moral and aesthetic worldview of future doctors, the ability to formulate and actively defend their own point of view, the system of aesthetic values and priorities.

Prerequisites. For successful mastering of discipline, the student needs the knowledge received in the course of studying of the following general disciplines: «History of Ukraine and World History», «Man and the World», «Civic Education», «Fundamentals of Law», «Art Culture», «Fine Arts», «Musical Art», «Ukrainian Literature», «Foreign Literature»

The purpose of the course and its significance for professional activities there is a worldview and cognitive training of medical students, the formation of theoretical basis of the university level of training and the actualization of the humanistic consciousness of the future medical elite.

Postrequisites. In the process of studying the discipline, a student acquires knowledge, which is necessary for successful mastering of professional training disciplines, namely: «Philosophy», «Sociology and Medical Sociology», «Political Science», «Fundamentals of economic theory», «History of medicine», «History of world culture», «Medicine and art», «Aesthetics and theory of art», which involves the integration of teaching with these disciplines and the application of acquired knowledge, skills and abilities in the process of further education and professional activities.

3. Learning outcomes:

formation of the culture of the future doctor's personality on the basis of humanism and universal values, under the conditions of mastering the basic set of general and special competencies, theoretical and methodological knowledge of the discipline and practical skills and abilities.

After successful study of the discipline the applicant will be able to:

- independently determine the essence and content of cultural phenomena in the course of historical development, analyze the features of cultural and historical epochs;
- operate with methods of historical and systematic analysis, compare the features of different cultural eras;

- to analyze the causes and consequences of changes in human attitudes to man, society, nature in different historical periods;
- to substantiate the cultural influences of previous periods on the following ones, to prove the existence of socio-cultural dynamics;
- to find parallels of cultural development of separate historical epochs with the present;
- outline trends in further cultural development, taking into account historical and cultural patterns;
- to analyze the features of cultural development of different regions of the world;
- be able to explain the relationship and interactions of world and Ukrainian culture;
- to form a personal system of value orientations, communication skills;
- apply knowledge of the history of world culture to determine the line of personal behavior in a diverse culture;
- assess the importance of the subject for the formation of a modern specialist with a high internal culture.

4. Content and logistic of the discipline

The course includes 10 topics, which are divided into 1 thematic modul.

- Topic 1. Introduction to the course. The essence of culture.
- Topic 2. Art as an aesthetic phenomenon.
- Topic 3. The culture of the primitive period
- Topic 4. The culture of the Ancient world.
- Topic 5. Culture of the Middle Ages (V–XIV centuries).
- Topic 6. Renaissance culture (XIV–XVI centuries).
- Topic 7. Culture of the Age of Enlightenment (XVII–XVIII centuries).
- Topic 8. 19th century culture
- Topic 9. 20th century culture
- Topic 10. World culture of the XXI century in the context of globalization

The lecture course discovers the problematic issues of the relevant stages of the history of world culture.

Practical classes provide a theoretical justification of the main issues of the topic and the acquisition of the following practical skills:

1. know and be able to select literature and Internet resources for the preparation of reports, presentations and for participation in seminars, be able to attach information materials to the context of the program material;
2. to form culturological knowledge in speeches, reports, presentations;
3. give a review of the work of art (optional);
4. know and describe the creative activities of prominent representatives of world culture;
5. operate with methods of historical and systematic analysis, compare the features of different cultural epochs;
6. define the categories and basic concepts of culturology, interpret and use in everyday life the basic terms and concepts;
7. determine the species, genre and stylistic diversity of art;
8. to distinguish artistic and aesthetic directions, to substantiate their essence, originality and influence on public life.

In practical classes, students report, discuss, reasonably defend their views and positions, formulate conclusions on the topic and solve tests.

The student's independent work involves preparation for practical classes, studying topics for independent extracurricular activities, preparation of presentations, tables, albums, posters, elaboration

of scientific literature and writing reviews on the provided topics. Control of mastering the topics of independent extracurricular work is carried out in the classroom and the final control of the discipline.

Thematic plans of lectures, calendar plans of practical classes, thematic plan of independent extracurricular work, volume and directions of individual work are published on the site of the department.

7. Policy of discipline / course

The student has the right to receive high-quality educational services, access to contemporary scientific and educational information, qualified tutoring during the study of discipline and mastering practical skills. The policy of the department during the providing of educational services is a student-centered, based on normative documents of the Ministry of Education and the Ministry of Health of Ukraine, the Statute of the University and the Procedure for the Providing of Educational Services regulated by the main principles of the organization of the educational process in National Pirogov Memorial Medical

Adherence to the rules of National Pirogov Memorial Medical University, Vinnytsya, safety techniques in practical classes.

Instruction on safety and behavior during the signal «Air alarm!» is conducted at the first practical lesson by the teacher. The instructed students are registered in the Safety Instruction Journal.

Requirements for preparation for practical classes.

The student should be prepared for a practical lesson, testing tasks for the current topic should be solved in a workbook, diagrams and tables are filled.

A student should come to class on time, without delay. A student who is more than 15 minutes late is not allowed to the practical class and must work it in the prescribed manner.

The student must follow the rules of safety in practical rooms and at the department.

When discussing theoretical issues, students should demonstrate tolerance, courtesy and respect for their colleagues and the teacher; when performing practical tasks, the workplace should be kept in order and be cleaned after performing practical work.

Usage of mobile phones and other electronic devices.

The use of mobile phones and other electronic devices in the classroom is allowed only during electronic testing or surveys and performing search and group tasks.

Academic integrity. When studying the discipline, the student must be guided by the Code of Academic Integrity and Corporate Ethics of National Pirogov Memorial Medical University, Vinnytsya (link : <https://www.vnmu.edu.ua/en/general-information>) / Code of Academic Integrity). In case of violation of the norms of academic integrity during the current and final controls student receives a grade of "2" and must work it out to his teacher in the prescribed manner within two weeks after receiving an unsatisfactory assessment).

Missed classes. Missed classes are working out in the manner prescribed by Regulations of the Academic process in National Pirogov Memorial Medical University, Vinnytsya (link <https://www.vnmu.edu.ua/en/general-information>) at the time of work out schedule (published on the website of the department <https://www.vnmu.edu.ua/> Philosophy and Social Sciences Department #) to the teacher of the group or duty teacher. To work out missed lesson student must provide a completed workbook protocol on the relevant topic, answer questions in writing or orally to the topic of the lesson.

The procedure for admission to the discipline final control is given in the Regulation of the Academic process in National Pirogov Memorial Medical University, Vinnytsya (link <https://www.vnmu.edu.ua/en/general-information>). Students who do not have missed practical classes and received an average traditional grade of at least «3» are allowed to final control.

Additional points. Individual points in the discipline that student can receive for individual work, is determined by the results of his individual work according to Regulation of the Academic process in VNMU named after M. I. Pirogov (link <https://www.vnmu.edu.ua/en/general-information>) and policy of the course.

Conflict resolution. In case of misunderstandings and complaints to the teacher because of the quality of educational services, knowledge assessment and other conflict situations, student should submit his / her claims to the teacher.
